SPOTLIGHT: "ENTER LAUGHING"

Having recently returned from attending the Seventh Annual Whitetail Deer, Rio Grande Turkey and Colombari Pigeon Shoot held at Stan Studer's North Frio Yacht & Shooting Club somewhere south of San Antonio, where I was once again exposed to the appalling perversities that occur whenever permissiveness rears its hideous head at the poker table under the guise of "dealer's choice," which I suspect is a doctrine hatched by the forces of international Bolshevism as a device for eroding that reverence for traditional moral and spiritual values which find their expression in such institutions as freedom of press and assembly, the Puritan work ethic, bottled-in-bond whiskey, and Monday night football, I was pleased to find a letter from E. T. Thomas of Houston, Texas, requesting that I send him a copy of the rules of a poker game called Hi-Lo-Moose which appeared in this column a decade or so ago.

Mr. Thomas wrote that he had carried the original column and several Xeroxes until they disintegrated, and offered to send me an oil well in exchange, but it occurred to me that other readers might be in the same situation, their copy of the rules worn to illegibility, and that some readers had learned to read only during the last ten years, so that I should consider repeating the rules in their entirety as a public service, especially as I need a column more than I need an oil well, and further that I should adjust the rules in accordance with the peculiar (and I use the word advisedly) ecological, zoological, and sociological conditions prevailing in South Texas.

Accordingly I present herewith the complete rules for playing Hi-Lo-Coyote, pronounced wither "ki-yoat" or "coy-yoaty," depending on whether you're of the Apache or the Sioux persuasion, my own preference being a return to the original Aztec "coyotl."

1. Each player shall be dealt his first card face up.

2. If it is a deuce, trey, or seven of clubs, he gets an extra card, face down, as a bonus (and thus plays with six instead of five cards).

3. If it's the queen or king of hearts, the player may, at his option, offer it to the player on his left in exchange for the right to commandeer any card of that player later in the same hand, swapping it for any card of his. The player on his left is free to decline the offer.

4. If it's a nine of any suit, he is entitled to exchange it at any time during play of the hand for any card, whether face up or down, of any other player; however if he exchanges it for a face-

down card he is obliged to turn that card face up, and if it's another nine-spot he is obliged to contribute half the chips in his pile to the pot, immediately.

5. If it's the ace of spades or diamonds, all the rest of his cards must be dealt face up; if it's the ace of hearts or clubs, he's obliged to drop out of the hand, forfeiting his ante, but may sell the ace to the highest bidder before the next card is dealt.

6. If it's a red trey, the player is declared an Honorary Varmint Caller and is obliged to go outside not closer than 50 feet or farther than 100 feet from the building in which the game is being played and there, with or without the aid of a calling device, make sounds in imitation of a dying jackrabbit. If a coyote appears within 2 minutes and is witnessed by at least one other player or kibitzer, all deuces, treys, and one-eyed jacks in the player's hand become wild cards. If a bobcat also appears and is duly witnessed, the caller is entitled to declare any card in his hand wild. If either the coyote or the bobcat is albino, the player may declare one red card and one black card in his hand to be wild. If an armadillo appears, the caller is obliged to drop out of the hand, forfeiting his ante. If the armadillo is albino, he also forfeits half the chips in front of him to the pot.

7. If the card is the five of diamonds, the next card dealt to him will be wild, unless it's another five or the jack of spades, in which case the second card is confiscated by the dealer and the player must play with only four cards or throw in his hand. If it's any other five-spot,

the player is obliged to speak only Tex-Mex until the hand is over, on pain of forfeiture of the hand.

8. The highest card showing makes the first bet, as in conventional stud poker, but the bet cannot be raised by any player whose card is the same suit as the bettor's, and *must* be raised by any player whose card is an eight-spot of any of the other three suits.

9. The next four cards are dealt face down and betting proceeds as in five-card stud, except that after the third and fifth cards all bets and raises must be in odd numbers, and after the second and fourth cards in even numbers.

10. On receipt of their fourth card, players must declare themselves as going for high or low or both, as in any high-low game, with the pot split evenly between high and low winners unless someone goes for both and wins; however, during major feeding periods as determined by the Solunar Table in the most recent issue of *FIELD & STREAM* available at the time and adjusted for longitude, the hi winner takes 60 percent of the pot with the low winner taking 40 percent; during minor feeding periods the lo winner takes 60 percent, etc., with each period considered to last for 30 minutes from the time down in the tables.

And a Frankfort, Kentucky, reader, whose name I'm unable to decipher, wants to know if a party of hunters, lacking poker chips and using overripe sirloins as the medium (or well-done?) of exchange, could be described as playing for high steaks.

Not by me, buster.

WELCOME

Dr. Anthony welcomed everyone to the first meeting of the All-College Council and noted his appreciation for their willingness to take on this added responsibility. He referred to the Council as the "Internal Board of Trustees." Dr. Anthony then noted that this Council was formed as another means of enhancing communication at CCCC. The Council will bring all areas of the College together to address college-wide issues and concerns and to further the spirit of community through a greater awareness of responsibilities at every level within the College. The Council will examine District plans and priorities, identify current and future issues and challenges, and recommend policies, procedures, and solutions in attempting to fulfill District needs. Dr. Anthony gave an example of an issue the Council might address - how to increase enrollment at Central Campus.

COUNCIL ORGANIZATION

It was decided by unanimous vote that the Council will meet on the 4th Monday of each month at 2:30 p.m. in the Board Room of the Central Campus. The next order of business was to select two at-large members representing areas of the College not presently represented.
